OFFICIAL RULES

**1. Eligibility:** RacingJunk.com's [2024 TurboKits Giveaway](#), (the "Sweepstakes") is open to all legal residents of the 48 contiguous United States and the District of Columbia who are 18 years or older, have internet access and a valid email account. All employees of MH Sub I, LLC (the "Sponsor"), its affiliated agencies, and their respective affiliates, licensees or agents (collectively, the "Sweepstakes Entities"), as well as their immediate family members (spouse, parent, child, sibling and their respective spouses) and anyone residing in the same household (whether related or not), are not eligible to participate.
