AMERICAN AUTOWIRE GIVEAWAY
OFFICIAL RULES

1. Eligibility: RacingJunk.com's American Autowire Giveaway, (the "Sweepstakes") is open to all legal residents of the 48 contiguous United States and the District of Columbia over the age of 18 with access to the Internet and a valid email account. All employees of MH Sub I, LLC ("Sponsor"), all associated agencies and their respective affiliates, licensees or agents (collectively, "Sweepstakes Entities"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether related or not), are ineligible to participate in the Sweepstakes. 4. Selection of Sweepstakes Winner/Odds: There will be one (1) winner. The winner will be selected by January 7, 2026. The winner will be notified via phone or email. The winner will be selected at random from entries properly submitted using the approved method during the Sweepstakes Period. In the event that a winner is disqualified for any reason, Sponsor may, in its sole discretion, award the applicable prize to an alternate winner. Any return of prize notification or prize email as undeliverable will result in forfeiture of any prize and an alternate winner may, at Sponsor's discretion, be selected.
